

## "DE-RADICALIZATION AND YOUTH EMPOWERMENT IN BALOCHISTAN: A DISCOURSE ANALYSIS OF THE DRAMA SERIAL 'DARWAZA'"

### ABSTRACT

Media have always been used to present counter narrative and an instrument of molding the opinion. Entertainment -Education, Social cognition and Media Development strategies are the techniques that have been used by media to penetrate in the society and take hold on society and its perception. It stimulates the reasoning of society and make them able to reform their behavior by presenting them modal behavior. Prior research has found media as a tool of de-radicalization and presenting counter narratives. Radicalization is highly significant in Balochistan and it should be addressed. In this research the researcher has attempt to identify how drama serial "Darwaza" address the issue of radicalization and endorse de-radicalization in Balochistan. In this qualitative research (deductive approach) by the critical discourse analysis of drama serial "Darwaza", the researcher has identified the role of "Darwaza" in de-radicalization in the youth of Balochistan. Based on the critical discourse analysis, the researcher has suggested that functions and strategies of media like surveillance and entertainment - education to present the counter narrative of Pakistan.

### INTRODUCTION

Radicalization is a procedure described as ascend of obligatory use of aggression and strategic alliance in political tussle. According to Schmid Radicalization does not have structured definition. It varies from people to people but specialists have described it as individuals or group of people with intense communal religious or political views that refuse dominant socio-political views of society (Schmid, 2013). Radicalization is change in perception in a group of people that leads to their group ideology, and that ideology is dispersed in society with force.

De- radicalization is a reversal procedure of radicalization. Process of de- radicalization is often

taken as distraction (demilitarization) of radical assemblage, but it is behavioral and attitude change in the radical (Rashid & Naseer, 2019). De-radicalization has three levels, which are categories as micro, meso and macro level. At micro level, it is described as individual change, in which a radical distance himself from radical group and disengage himself from violent behavior due to the change of perception and behavior.

To de-radicalization the radical movements in Balochistan and international propaganda media has to play its role. As it the only soft step towards the solution of the problem rather than military action because the infrastructure and dynamics of Baloch land support militant. World's super power America could not conquer the militant in Afghanistan. So media can be used as a tool of de-radicalization as it is established reality that media has an ability to mould the opinion of common people. Media can use number of programming genres for this purpose for example talk shows, documentaries, dramas, cultural promotional programs (Beenish Zaheen et al., 2021).

Media have always been used as an instrument social change throughout the world since its birth. Functions, strategies and techniques of mass media are essential to bring the desired change in society. The British propaganda of Pearl Harbor brought America in to World War II and public opinion Americans got entirely change through British campaigns. (Cull, 1995). The strategies like education -entertainment has been proved more persuasive than simple messages. The researchers have suggested that entertainment education aries less resistance rather the percussive message which are designed according to narratives (Singhal, A., Cody, M. J., Rogers, E. M., & Sabido, M., 2004). Functions and strategies of media have been used to address the various social issues among which radicalization is significant. To counter the increased radicalization around the globe, counter narratives programs) are the initiatives, that are taken by governments to prevent their citizen away from the extreme activities (Harris-Hogan, S., Barrelle, K., & Zammit, A., 2016) Policy makers of de-radicalization have suggested media as a strong and vital component of message dissemination.

Above mention researches have proved media and media strategies as an important tool to deal with the issue of radicalization and de-radicalization. Drama serial "Darwaza" has address the issue of radicalization and de-radicalization in the youth of Balochistan. This research will explore the discourse of drama serial "Darwaza" to find out how drama serial "Darwaza" has been used as a tool of de-radicalization in the youth of Balochistan.

### **Objectives of Study**

- To explore how drama serial "Darwaza" address the issue of radicalization and endorse de-radicalization in the youth of Balochistan.

### **Research Question**

- How drama serial "Darwaza" address the issue of radicalization and endorse de-radicalization in the youth of Balochistan?

### **Significance of Research:**

This study is highly significant as it address the most crucial issue of Pakistan that is radicalization in Balochistan. The researcher has analyzed the role of media regarding

radicalization in Balochistan and how media has contribute in the de-radicalization of the radials of Balochistan. For this purpose the researcher has done " Critical Discourse Analysis" of Drama "Darwaza" to unearh the in-depth understanding of role of media in de-radicalization in Baluchistan.

This Research is limited in scope as it is has analyzed only one Drama. It did not analyzed other genres of programming in media. This research will help the researcher in designing other media content to address the issue of radicalization in Balochistan. It helps the policy makers in scheming media policy regarding de-radicalization in Balochistan

## Literature Review

De-radicalization has been defined by the UN CTITF(2008) as: "a set of organized strategies designed to cater such situation that may lead the group of people towards extremism, It refers to the political ,economic, social and educational deals purposely intended to discourage the people from taking extreme steps" The researcher has studied phenomenon of radicalization and de-radicalization with different research methodologies. Randy Borum (2011) explained how radicalization turns into extreme violent acts by adopting explanatory research method. In addition Demant and & GRAAF (2010) has explained counter radicalization in his article with help of case study method. The researcher compared and explain theoretical and historical concept of demands and supply with the help of case studies of Moluccans and Islamic radicals.

Ashour (2010) in his article elaborates the strategies, role of media and characteristics of message and messenger. The researcher has done the research by analyzing the prior researches and explanatory research method. Hardy (2018) did comparative analysis of the countering violent extremism policies of United Kingdom, Australia, Denmark, Sweden and The Netherlands by case study method. Brown and Saeed (2015) studied radicalization and counter radicalization with methodology of interview and explain the alternative and encounter of Muslim student in British Universities.

Media is an influential tool to cater radicalization, as it has an ability to shape the opinion of common people. Wilbur Schramm, father of Communication Studies, clarify the role of media in for the betterment of society in following words:

"By making one part of a country aware of other parts, their people, arts, customs, and politics; by permitting the national leaders to talk to the people, and people to the leaders and to each other; by making possible a nation-wide dialogue on national policy; by keeping the national goals and national accomplishments always before the public--thus modern communication, widely used, can help weld together isolated communities, disparate subcultures, self-centered individuals and groups, and separate developments into a truly national development."

Owing to Schram's (1964) explanation communication means (mass media ,social media), it is concrete reality that media is act in unifying the people against state discussions regarding their rights, weather the decisions are in the favors of public or against them . It promote the social responsibility and provide base to the socially awaked activities. Ahmad (2014) explained in his article that , electronic media monitors the performance of governments. New and current affairs programs which are famous among the public nowadays are providing us better understanding of social and political issues. Media has proven its power as a game changer centuries back when

"Pravada" transform the decaying Tsarist Russian society into the super power of Communist Russia.

Media and opinion shaping has always been a great debate among the scholars of media. They have developed hundreds of theories that explain the power of media as an agent of shaping an opinion. The earlier theories of media which later faded away, Magic Bullet Theory is an example which made media so powerful media that can affect the behavior of individuals directly, consumers of violent movies are more violent in real life then others ( DeFleur M.L., & Sandra B.R, 1989) later this concept was denied by Two step Flow theory . Lazarsfeld and his colleagues argue that media messages does not affect the audience directly , it is opinion leader who interpret media messages for common people (Bob, 2005).

The research that have been conducted to measure the power of media as an agent of changing opinion , includes inductive and deductive approaches. The most popular method to carry out these researches contain empirical observations, surveys and case studies field experiments. Lazarsfeld, empirical media researcher has gained popularity in the history of media research by applying scientific research method in to solve social problem.. His famous `contribution "Amarican Voter Studies" , he used field experiment and survey method to observe the magnitude and influence of media over public opinion (Baran, 2013). Most recently similar study to measure the power of social media as a catalyst of social change , the researcher used deductive approach with cross-section survey method to measure the relationship between social media and social change. (Mangi, 2018)

Crisis of Balochistan are increasing day by day and hatred against Pakistan in the society Balochistan in increasing respectively. There are lots of reason of this hatred, among which "political tussle between political tussle between federation and the region" that makes the situation worst for the development of Balochistan as it generate the major problem regarding "infrastructural and financial improvement" of Balochistan (Aasim, 2007). The people of Balochistan has stood against the federation for their rights for many time because they consider it their right to have an equal representation in federation and economics (Harrison, 1981). Other than domestic reasons , the role of foreign actor in making the situation worse , cannot be denied. Balochistan is located at high important strategic location, CPEC and Gawadar has become an apple of discord among the global powers like America , China , India , UAE , Russia, peace in Balochistan doesnt suite to these powers so they keep the air of hatred high in Balochistan against Pakistan (Javaid, U., & Jahangir, J., 2015)

The hatred that has been prevailing in the society of Balochistan is not different then the hatred that has been observed in the society of Bangladesh during 1971, and it can bring the same result (Akhter, 2013). Balochistan is critical for Pakistan and radicalization that prevails in Balochistan is alarming for Pakistan. This radicalization have any reasons among which economic exploitation the main( Bengali ,Pasha, 2005). Secondly Balochistan has gained highly importance in regional affairs, all the global powers like China America ,Russia ,UAE and India have kept their eyes on Balochistan for their interest, and they do not want a stable Balochistan to cash their interest at maximum. (Javaid, U., & Jahangir, J., 2015) The international actor are one of the big reason who created an atmosphere of radicalization in Balochistan

The geographical position of Balochistan has make it a crucial area not just for Pakistan but it also

has become a decision maker of foreign relations and priorities of global powers . As it is preeminent nautical passageway in the Indian sea, Balochistan has expanded a highly significant position between the super powers of the world by creating an intensified demand for invading and governing sea route . Sole and exceptional corporeal natural features of Balochistan is taking on high importance in regional political affairs.

Available literature suggested that media has power to mould the opinion and make people think according to decided agenda that media (or the powers who are controlling media ) has designed for them . This power of media has been used to cater the issue of de-radicalization throughout the world and similarly this power of media can be used to deal with the issue of radicalization in Balochistan and media can be used as a tool of de-radicalization in Balochistan. Balochistan is key for a better future of Pakistan. To cater this radicalization and international propaganda media has to play its role.

### **Media Development Theory:**

Media theory relates to the matrix of idealistic and social political concepts that coordinate theories regarding the interaction with in media and society. That is a form of philosophy named 'normative ideology,' which deals with what the media needs to do in culture in spite of what media has done, which means prevailing views about the responsibilities of mainstream media should be compatible with certain principles and practices in a specific community.

Primary assumptions of development media theory are, national development, establishment of democracy, informational and cultural sovereignty and solidarity

Drama serial "Darwaza" is more or less an explanation or narrative of Government of Pakistan over the issues of Balochistan. it advocates the efforts of the government of Pakistan on the development and state the agenda of government over the issue of radicalization. Drama "Darwaza" has adopted the strategy of entertainment-education to educate the people of Balochistan regarding the hidden propaganda of foreign elements in radicalization, it elaborated the significance of harmony as a need of time. That is why the researcher has selected the theories of social cognition and media development along with the entertainment - education strategy, as they best elaborate the discourse of drama "Darwaza".

### **METHODOLOGY**

Discourse analysis is explicate as arrangements and practice that reveal human thinking and social realities by specific anthology of words and that at the same time create significance in the world (Fairclough, 2003). According to Yanow (2000) Critical Discourse Analysis (CDA) is a research methodology that is adopted for decode the discourses to find out power relationship. "from epistemological standpoint, it presupposes the multiple possibilities of knowing and interpreting the world". Discourse analysis is explicate as arrangements and practice that reveal human thinking and social realities by specific anthology of words and that at the same time create significance in the world (Fairclough, 2003).

This researcher has taken Drama serial "Darwaza" from the perspective of de radicalization of youth in Balochistan .This drama is aired on PTV Bolan . As PTV Bolan is only state channels that deals with Balochistan individually and it is only channel that can disseminate the stance of

government over the issue of radicalization and can work together with government to de-radicalize the society of Balochistan which is a challenge for government of Pakistan.

Critical discourse analysis helped to analyze the character of state and institution of media to address the issue of radicalization and how media work together with state to deal with social issues of society. As CDA "focuses upon the social problem. It starts by identification of the problem, chose the perspective of the victims who undergo the situation and decisively investigate the people who are responsible and who have mean to solve the problem" contextual analysis "Darwaza" will help us to figure out the cause and factors involved in flaming up radicalization in Balochistan and possible solution of the problem suggested in drama . Drama "Darwaza" is a serial of 14 episodes. The researcher ha analyzed 11 episodes with the reference of de-radicalization. The researcher has selected discourse on the basis of purposive sampling as the theme of de-radicalization has 7 prominent construct .In which social plight of Balochistan , radicalization and causes of radicalization , social insecurities , patriotism , social responsibility, deconstruction of aggressive behavior , dissection of stereotypical norms are being analyzed in this research.

The study of scenes and dialogues of drama "Darwaza" elaborates that drama is an effort to clarify the misconceptions of the society of Balochistan and to present them the true picture of their societal problems. The issue of radicalization is deep rooted in other societal problems such as poverty , ignorance, privation and fight of honor and identity that people of Balochistan are dealing with.

Drama begins with the scene of property dealer who Ghafar , who is aware of the significance and importance of land of Gawader .He came to establish his business and invite the investors to invest in the land of Gawadar and grab as much as they can, he tells investors that this land will turn into gold. On the other hand development in Balochistan is taken as the day of judgment by the common people who think that these development projects will take them away from their roots. The dialogues of Zainab drama reveals the health facilities .The health , poverty and identity crisis situation in cashed by politician who use these situations to raise the sentiments of youth in the name of "fight of rights

Episode 2 has introduced the working of political parties who are contributing in the radicalization of youth .They stop the educational activities and wash the brains of educated people in the name of "fight of rights". They distract the students from their true purpose of their lives and make them indulge into the political activities such as protests and anarchy for their political gains. Even in their speeches they challenge the writ of government and make the young stand in front of their own government. On the other hand the youth which is spare of the influence of these political leader are shown hopeless, and drench into ignorance and intoxication .

Ghufar the property dealer who is scold by Gulam Qadir who does not want to sell his identity or land. He gambits and grab the older son of the family to stand against his father by showing him the delusion of better future. While the youth which has been brain washed by politician has so much indulge into the politics that they do not even participate in the most important events of family

In episode no 4 the narrative of Pakistan over radical activities and protest against development or government has been disseminated . Here social cognition theory has been applied and narrative of Pakistan has presented in a way that stimulate the retinal of viewer. Police officer (S.H.O) firstly describe the hatred based activities of protester and then tries to shook the radicals about their unjustified acts , he clarifies them that Pakistan police and administration is there for their protection, by giving touchy argument to gain the sympathies of viewers. In scene no 19 drama reveals the usability of society where government of Pakistan dealing with radical activities such as bomb blast . While brain washed youth is not ashamed of their acts of anarchy and still stick to their stance that the development projects are the demolishing projects of their identity.

Another episode present the opportunist is making innocent poor people fool in the name of development just to gain his maximum. This character is an abstract representation of who are present there in Balochistan and they just have their own interest . They are working on their own agenda of maximum gains and to earn gains they are contributing in destabilizing the society by making brother fight with each other and of course the role of black sheep

Episode No 6 has pointed out the youth which is drenched into intoxication and their only

hope of survivals is their jobs in gulf countries. Episode no 7 presents the conversation of police officer present the other side of the coin to the viewer and stimulate their reasoning . He blames Murtaza for the feeble minded society of Balochistan and ask him why did not he raise the voice against illiteracy , ignorance in society ?. Why did not he make people strong enough to embrace the development them self ? Instead he is misleading the society that the development is conspiracy and projects are curse for them .

Episode no 8 revealed the situation of the family who has difference of opinion regarding developmental projects in Gawader (Balochistan). One of the brother is there to embrace the development for the sake of better future and the other one is ready to take his life even, to secure the identity of his ancestors (Referring to scene no 1). Lately the stance of the brother who is in the favor of development project has been told with an emotional appeal and tried stimulate the viewer by providing them food for thought that they must think about their future generation. Do they want to up bring their child in same social plight ? (Referring to scene no 7)

Episode no 9 has shown the youth who has reached to the point where he took the gum against his own brother by being impressed by the sentimental speeches of political leader and he is ready to defend his identity with his gun and for his vision he can kill his brother even. (Referring to the scene no 6 ) The older people of Balochistan are afraid of instability caused by development projects (Referring to scene no 8 ) Scene no 11 explains the situation to viewer and it address the older people that soil is not everything ,until to make it utilize for betterment , and those who can understand the real worth of land deserve to cherish its fruits.

Episode no 10 is the further explanation of the situation of development and confusion in mind of people of Balochistan has been clarified ,with the reference to the narrative of government of Pakistan. The government officer Muhammad Bakhsh presents the vision of Pakistan in front of the people of Balochistan who are rigid to embrace the development. The viewer has been address in very sympathetic way and explanation of the misconception has also been address . The thought provoking dialogues of the officer is an attempt to raise the question in the mind of viewer regarding the right of their land upon them. It ask people why they just want to be fishermen ? Why cannot they dream big as they have been blessed with best region which is been the dream of super powers ?

Episode no 11 present the solution of the greatest problem of Baloch society , that the people of Balochistan are not ready to give up their land in the name of development no matter what harm it may bring to them. It presents the solution of the problem which is been given by Muhammad Bakhsh (government officer ) that again inculcate the message sincere efforts by government of Pakistan, that government is concerned with the insecurities of Baloch society and they sincerely want to address their concerns regarding development projects. Ghulam Qadir tells Murtaza that he will make a deal with investors of developmental project on the pattern of Dubai and other countries of the world . He will remain the owner of the land and investor can use his property on equal profit sharing

## CONCLUSION

Media is an instrument of social change as it is a tool that carries information and education which plays a key role in social development and perceptual change . Media has an ability to

It gave the message to the radicals to fight against the real enemies of Balochistan rather expanding their doubts upon the sincere efforts of development by state. It de-radicalize the radicals through the character who has been an inspiration to them and condemn the radical activities through their opinion leader and leave it up to viewer to analyze each and every aspect and make decision of their own weather radicalization is in the favor of prosperity of Balochistan or sincere efforts of the state who is ready to address all their insecurities and making best attempts to make Balochistan a prosperous land.

### Recommendations

- Media should try to explain the root cause of radicalization ( international actors , economic deprivation etc. ) to the people so that they try to understand the stance of Government of Pakistan and came forward to solve the issues of table rather with aggression .
- Media can mould the opinion of the radicals of Balochistan by running awareness campaigns to unveil the international propaganda and their interest in separate Balochistan
- Illiteracy one of the major cause that let Baloch people pray of international propaganda . In order to deal with this type of situation, radio especially, Community Radio can help to reach out to a large number of masses. It can be used as counterbalance the hatred and a medium of propagation of set agenda of Pakistan.
